Vide reference 1st cited, the Chief Engineer/Visakhapatnam Zone has proposed to spare land of AP Transco to an extent of 608.85 Sq mts to M/s GVMC for relocating structure of Road widening and junction improvements in BRTS by taking the cost of land for an extent of 1078.96 Sq mts (i.e., 470.11 Sq Mts were already transferred) to acquire/purchase land to the following proposed Sub-station.

1. 400 KV SS in Vizianagaram.
2. 132 KV SS/Lankelapalem.

The present market value of the land taken from Joint Sub-Registrar-I on 21.08.2011 for the Door.No.16-683 to 16-686 is Rs,10,000/- per Sq. Yard. The cost of the proposed land of AP Transco as follows.

For Road widening - (470.11 Sq.Mts) 562.247X10,000=56,22,470-00
(Already taken)
For relocating - (608.85 Sq.mts) 728.178X10,000 =72,81,780-00
(Proposal-A) structures

Total: = 1,29,04,250-00

Further, the Chief Engineer / Visakhapatnam Zone / Vishakapatnam requested to issue necessary instructions on above said land.

The Commissioner/GVMC/Visakhapatnam vide reference 3rd cited has requested the Chief Engineer/Visakhapatnam Zone to transfer the required 608.85 Sqm land of APTRANSCO (220/132/33 KV) Diary Farm at Chinnagadhili, to GVMC in lieu of that the land required to be transferred by GVMC to APTRANSCO at equitable cost equivalent to the value of the land 1078.96 Sqm (i.e., 470.11 Sqm already transferred) to be allotted to APTRANSCO as per availability of GVMC land either at Lankalapalem or at
