APTRANSCO – O&M ESTABLISHMENT – PROMOTION TO UNQUALIFIED O&M STAFF TO NEXT HIGHER POST – EXEMPTION OF SERVICE ON ONE TIME BASIS – ORDERS –ISSUED.

P R O C E E D I N G S :

The employees Unions represented for relaxation of 10 years service on one time basis for considering promotions to O&M staff duly extending the T.O.O.under reference cited where qualified candidates are not available.

2. The above issue has been discussed in all CMDs Meeting (APPCC meeting) and after careful consideration and further to the orders issued in T.O.Os cited, approval is hereby accorded to promote unqualified candidates in the cadre of JLM to ALM and ALM to LM for filling up of vacancies on one time basis subject to the following conditions:

- i) The exemption from possessing educational qualification by the unqualified candidates shall be applicable only in the divisions where the unqualified candidates cannot be promoted to ALM/LM cadres due to absence of qualified or even after all the available qualified candidates are promoted as per O.S.S. rules.
- ii) The existing ratio of 4:1 between qualified and unqualified candidates shall be followed. The unqualified candidates shall be considered for exemption only after earmarking the vacancies equivalent to the number of qualified candidates available as on date in the Division. The remaining vacancies earmarked for qualified candidates shall be filled by unqualified candidates, wherever necessary.
- iii) The unqualified candidates shall be considered for promotion only if they happen to be seniors to the qualified candidates and in no case a qualified candidate shall be superseded by a junior unqualified candidate.
- iv) The exemption is applicable to the vacancies available as on the date of issue of the orders and not to any vacancies arising subsequently.
- v) This exemption shall not apply for promotion from LM to LI cadre
- vi) The employee claiming exemption for education qualification shall otherwise be eligible as per O.S.S. rules.
- vii) A qualifying test consisting of reading and writing abilities, job oriented skills shall be held and only those who qualify in the test shall be eligible for exemption.
- viii) A Committee consisting of CE (Civil)/CE/Telecom or CE of Zones or CE nominated, SE/TLC, SE/TL&SS, SE/Civil of APTRANSCO, SE/(Operation) of DISCOM shall be the “DPC” and shall be responsible for conducting the qualifying test for determining eligibility for exemption.
- ix) The CE of Zones, CE/Civil, CE/Telecom of APTRANSCO and concerned SEs/DEs in DISCOMs shall be the appointing authority for the purpose of promotions effected under this exemption.
- x) For candidates who qualify in the test as per clause (vii) above, strict seniority should be followed while considering for promotion in the vacancies reserved for qualified candidates.
