The Superintending Engineer/TLC/Karimnagar vide reference 1st cited was authorized to deposit an amount of Rs.4,00,521/- (Rupees Four Lakhs Five Hundred and Twenty One Only) for the land acquired to an extent of Ac.1.32 gts at Nadpally (V) for construction of 220 KV Sub-station Dichpally in Nizamabad District with the RDO & LAO/ Nizamabad towards decretal charges in O.P.No.10/2003.

Vide reference 2nd cited, the Superintending Engineer /TLC Circle/ Karimnagar has requested to sanction an amount of Rs.9,00,917/- (Rupees Nine Lakhs Nine Hundred and Seventeen Only) for the lands acquired to an extent of Acres 3.26 ³/₄ Guntas in Sy.No.337 (old) 351/2 (New) for construction of 220 KV Sub-station situated at Nadpally Village of Dichpally Mandal in Nizamabad District towards decretal charges to be deposited with RDO & LAO/Nizamabad as per O.P.No. of 321/1991.

The RDO & LAO/ Nizamabad in the reference 4th cited has informed that the petitioners Sri.Balla Ramulu and (3) others who have not filed protest petitions U/s.18 of L.A.Act have applied joint application U/s. 28 (A) of L.A.Act on 1.4.1999 along with certified copy of judgement in O.P.No.321/1991, dt.26.11.1998 for re-determinaion of compensation U/s.28 (A) of L.A.Act on par with the awardees covered in the judgement in O.P.No.321/1991 and judgement in A.S.No.1686/2000 and cross objections (SR) No.7595 of 2008 of Hon'ble High Court of A.P., dtd.12.08.2008.

The RDO & LAO/Nizamabad has calculated the decretal amount which has been approved by the Joint Collector, Nizamabad and has been sent to the Chief General Manager (H.R.D), APNPDCL, Warangal requesting to deposit an amount of Rs.9,00,917/- (Rupees Nine Lakhs Nine Hundred and Seventeen Only) in the name of RDO & LAO/ Nizamabad for making payment of compensation to the land owners. In turn, the Chief Engineer/ Warangal Zone has directed the Superintending Engineer/ TL & SS Circle/ Nizamabad to deposit the said amount with the RDO & LAO/ Nizamabad.
