Change of name of 132/33KV Pochampadu Substation as 132/33KV Bussapur Substation – Approval – Accorded.

Proceedings: -

1. The Sarpanch Bussapur Gramapanchayat along with village representatives of Bussapur village, Balkonda (Mandal), Nizamabad (District) vide their letter dt.3.5.2011 have represented the following:
 - (i) The existing 132/33KV substation and 33/11KV substation at Pochampadu are located in the premises of Bussapur village Gramapanchayat, Balkonda (Mandal), Nizamabad (District) bearing Survey No.42/1, 42/2, 42/3 & 42/4 covering 8 acres 36 guntas land.
 - (ii) Property tax for the above substations was paid to Bussapur Gramapanchayat upto the year 1988-89.
 - (iii) Resolution made in the Bussapur Gramapanchayat meeting dt.11.3.2011 (Friday) towards change of name from 132/33KV Pochampadu substation to 132/33KV substation Bussapur.
 - (iv) The Tahasildar of Balkonda Mandal vide letter No.C/1274/2011, Dt.10.3.2011 has certified that Electric substation constructed in the survey No.42/1, 42/2, 42/3 & 42/4 at Bussapur village of Balkonda Mandal and which is attested by Revenue Divisional Officer, Nizamabad.
2. They have requested to change the name of existing 132/33KV Pochampadu substation as 132/33KV Bussapur substation.
3. After careful consideration, APTRANSCO accords approval for change of name of existing 132/33KV Pochampadu substation as 132/33KV Bussapur substation as it is located in the premises of Bussapur Gramapanchayat, Balkonda (Mandal), Nizamabad (District).
4. Hence, the name of existing 132/33KV Pochampadu substation may be read as 132/33KV Bussapur substation from the date of issue of this T.O.O.
