APTRANSCO – O&M of EHT sub-stations and Lines (CBD Gang) on contract basis – Revision of wages to contract labour – Amendment - Orders – Issued.

Ref: T.O.O.CE(Transmission) Ms.No.429, Dt.07-02-2012.

Order:

In the T.O.O. cited above, the wages of the contract labour were revised w.e.f.17-01-2012. Recently it was brought to the notice of the management by the field officers that some of the contract labours engaged under un-skilled category for miscellaneous works like watch and ward, gardening & House Keeping etc., (for which no education qualification is required) have requested for payment of revised Highly skilled/Skilled wages to them as per above T.O.O. as they possess Diploma/I.T.I. qualification. By mere possessing the qualification and allowing of wages on the pretext of their qualification cannot be considered for payment of wages on par with the Highly skilled/Skilled persons.

2. In view of the above, the following amendment is issued to clause No.2(i) of the above cited T.O.O. to be read as follows:

Para No.	Existing in T.O.O. Ms.No.429, Dt.07-02-2012	To be amended as
2 (i)	The contract labour engaged in APTRANSCO with the qualification of Diploma In Engg. shall be categorized as highly skilled labour instead of skilled labour and with the qualification of ITI shall be categorized as skilled labour instead of semi-skilled labour. There is no change for un-skilled category of persons.	The contract labour engaged for O&M works of EHT sub-stations in APTRANSCO with the qualification of Diploma in Engg. and those attending jobs involving high degree of skill of judgement and to capacity to supervise shall be categorized as highly skilled labour instead of skilled labour and with the qualification of ITI and those attending jobs which demands skill and capacity to work independently shall be categorized as skilled labour instead of semi-skilled labour. There is no change for un-skilled category of persons. <u>The contract labour engaged for works other than the above are not entitled to claim remuneration on par with Highly skilled/Skilled though they possess Diploma/ITI</u>

All other terms and conditions mentioned in the above cited T.O.O. remains unaltered.
