APTRANSCO – O&M of EHT sub-stations and Lines (CBD Gang) on contract basis – Revision of wages to contract labour – Orders – Issued.

Read the following:-

Order:

The wages are being paid to the contract labour in APTRANSCO as per G.O.Ms.No.6, Dt.18-08-2009 issued by Commissioner of Labour, Andhra Pradesh. The Labour Commissioner, Andhra Pradesh vide G.O.Ms.No.11, Dt.17-01-2012 has revised the category and wages in respect of the contract labour duly indicating the qualification with a provision for payment of dearness allowance for every six months. The same have to be adopted by APTRANSCO.

2. After careful consideration, APTRANSCO accords approval for the following:

- i) The contract labour engaged in APTRANSCO with the qualification of Diploma in Engg. shall be categorized as highly skilled labour instead of skilled labour and with the qualification of ITI shall be categorized as skilled labour instead of semi-skilled labour. There is no change for un-skilled category of persons.
- ii) To adopt the new wages for payment to the contract labour engaged by APTRANSCO w.e.f. 17-01-2012 as per the details mentioned below:

- iii). The Dearness Allowance (cost of living allowance) released for every six months i.e 1<sup>st</sup> April and 1<sup>st</sup> October of the calendar year as notified by Commissioner of Labour is payable to contract labour. .
- iv). The payment of wages to contract labour working in special maintenance gangs in sub-stations and in CBD Gangs on transmission line side are to be paid as per highly skilled category as shown in the above table.
- v). The payment of above revised wages shall be implemented from the date of issue of G.O. (i.e.) w.e.f 17-01-2012.
- vi). The above revised unskilled wages are to be paid to the private security persons as per the agreement engaged at 59 Nos. EHT sub-stations for the period from 17-01-2012 to 31-03-2012.
- vii). The above revised category and wages shall be incorporated in the fresh tenders being called by zonal Chief Engineers for awarding the O&M of sub-station and lines works. The administrative charges of 10% to 15% shall be incorporated in the fresh tenders instead of 15% to 20%. The Administrative charges payable to the contractors shall be on basic wages only excluding Dearness Allowance.
- viii). The EPF & ESI are payable on basic wages and Dearness Allowance. The professional tax shall be deducted from the wages of the contract labour. The service tax is payable on gross amount of the wages.
- ix). To reimburse the Toll tax paid by the contractors for movement of hired 3 Ton van engaged by CBD Gangs works on production of proof of payment of Toll tax.
- x) The FA & CCA (CF), Vidyut soudha shall release the additional budget required for meeting the expenses due to revision of wages to contract labour and release of Dearness Allowance from time to time.

3. This order is issued with the approval of Director (Finance & Revenue) vide Regd.No.480, Dt.04-02-2012 and CMD/ APTRANSCO vide Regd. No.380, Dt.06-02-2012.
