3. The AE/AAE/Elecl. post diverted in T.O.O. (Per-CGM(HRD&Trg) Rt.No.518, dt.8.11.2010 for attending to ULDC works and Energy meters shall be now kept under the control of newly formed ADE/MRT/ GIS Substations& Automation.
