ORDER:

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs - Part-II, as adopted by A.P TRANSCO, Sri V. Swamy Naik, Assistant Divisional Engineer/Elecl., is promoted temporarily to act as Divisional Engineer/Elecl., with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is without prejudice to the seniority of the Officers that will emerge after review of F.C.G List of Asst. Engineers of Electricity Department as on 01-11-1956.

4. The promotion ordered is subject to result of Writ Appeal filed by the retired officers of erstwhile A.P.S.E. Board against the judgement in W.P.No.2360-91/1983 and pending in the Hon'ble Supreme Court. The promotion is also subject to result of Writ Petitions pending in the Hon'ble High Court of A.P., regarding seniority.

5. Sri V. Swamy Naik, Assistant Divisional Engineer/Elecl., on temporary promotion as Divisional Engineer/Elecl ordered in para-1 is transferred and posted as DE/TL&SS/Yerraguntla under the control of CE/Zone/Kadapa vice Smt P. Nageshwari, DE/Elecl transferred.

6. Smt P. Nageshwari, DE/TL& SS/Yerraguntla is transferred and posted as DE/PM-I/O/o CE/Const-I/VS/Hyd in place of Smt J. Uma Rani, DE/Elecl., promoted as SE/Elecl. She is requested to assume charge at the place of posting ordered after obtaining proper relief at the present place of working.

7. The Controlling Officer is requested to relieve the above promotee by making local arrangements pending posting of substitute to enable him to assume charge on promotion as Divisional Engineer/Elecl., at the place of posting ordered.

8. Sri V. Swamy Naik, Assistant Divisional Engineer/Elecl is requested to assume charge on promotion at the place of posting now ordered after obtaining proper relief at the present place of working.

The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly within 15 days from the date of receipt of the order failing which he has to forego all the rights both at present and in future for such higher posts. If he fails to join duty within the time limit or evades to join duty such period till he re-joins will be treated as un-authorized absence besides treating such period of un-authorized absence as DIES-NON. He shall also be liable for disciplinary action.
