**ORDER:**

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs - Part-II, as adopted by A.P Transco, Sri M.L.Narasimham, Asst. Accounts Officer is promoted temporarily to act as Accounts Officer with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

6. The concerned Controlling Officer is requested to relieve the above Assistant Accounts Officer by making local arrangements pending posting of substitute in order to enable him to assume charge on promotion as AO at the place of posting ordered.

7. The promotee is requested to assume charge on promotion as AO at the place of posting ordered, after obtaining proper relief from the present place of working.

8. The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly within 15 days from the date of receipt of the order, failing which he has to forego all the rights both present and in future for such higher post. If he fails to join duty within the time limit or evades to join duty, such period till he re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. He shall also be liable for disciplinary action.



