ORDER:

The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly within 15 days from the date of receipt of the order, failing which he has to forego all the rights both present and in future for such higher post. If he fails to join duty within the time limit or evade to join duty, such period till he re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. He shall also be liable for disciplinary action.
