**ABSTRACT**

APTRANSCO – IR – Medical Insurance Scheme – Revision of Policy for the period from 01.10.08 to 31.03.09 for covering Diseases/Ailments and for covering pre existing Ailments as per Standard Group Mediclaim Policy – Orders – Issued.

**ORDER:**

In the T.O.O. 1<sup>st</sup> cited, the APTRANSCO issued orders for implementation of Tailormade Group Mediclaim Policy (with Floater) offered by M/s. National Insurance Company Limited to its employees with effect from 1.4.2008 subject to certain instructions issued therein.

2) In the reference 2<sup>nd</sup> cited, M/s National Insurance Co. Ltd has proposed to revise the premium @ 3,000/- (including service tax) per employee per year including (5) dependent family members (i.e Spouse, upto two children, parents or parents-in-law for female employees) which will be charged proportionately for the remaining period of six months of policy period **for covering diseases/ailments as per their Standard Group Mediclaim Policy and for covering pre- existing ailments**, after a pro-rata adjustment of the existing premium received. The medical bills will be admissible as per general tariff under this policy. In the case of dependents of the employees covered under this policy the maximum age limit prescribed as 85 years.

3) M/s National Insurance Co. Ltd has exempted the applicability of Clauses (4.1), (4.2) and (4.3) stipulated under the head of “ **(4) Exclusions**” in **Standard Group Mediclaim Policy** to the employees including their dependents of APTRANSCO.

4) The Policy is revised as discussed with all the Trade Unions and Associations of the employees. As per the revised policy, the balance premium will be **Rs.970/- per year per family** ( i.e.Rs.3000/- (revised) – Rs.2030/- (already paid)). As such, the policy may be revised with effect from 1.10.2008 to 31.3.2009 for the remaining period of (6) months and the balance premium of Rs.485/- (including service tax) for the period **from 1.10.2008 to 31.3.2009** per family consisting of members (1+5) may be contributed by the employer and employees. This revised premium may be made applicable to all the employees working in APTRANSCO, as was ordered in the T.O.O.1<sup>st</sup> cited.

5) Further, the Unions/Associations have requested for 24 Hours Helpline facility from M/s TTK Healthcare Services (P) Ltd, Hyderabad. They have also agreed to provide 24 Hours Helpline facility and the following Mobile Nos are available for availing Helpline facility.

6) After careful consideration and in partial modification to the orders issued in the T.O.O.1<sup>st</sup> cited, the APTRANSCO hereby directs that the balance premium revised by M/s National Insurance Co. Ltd shall be borne by the employer @ Rs.388/- and employee @ Rs.97/- towards contribution of the enhanced premium for the Policy period from 01.10.2008 to 31.3.2009 **for covering diseases/ailments as per their Standard Group Mediclaim Policy and for covering pre-existing ailments** and the employee contribution of Rs.97/- for the period from 1.10.2008 to 31.3.2009 shall be deducted from the salary of October, 2008 payable in the month of November 2008.

7) The other terms and conditions stipulated in the TOO 1<sup>st</sup> cited shall remain unaltered.

8) All the Concerned Officers are requested to take necessary action, accordingly.

9) These orders are issued with the concurrence of the Director (Finance & Revenue) vide Regd.No.2496, dt.15.9.2008.
