ORDER:

In the T.O.O. Vide Reference 2<sup>nd</sup> cited the AP TRANSCO issued orders in sub-para (ii) of para - 2 that, "the existing ratio of 4:1 between qualified and unqualified candidates shall be followed. The unqualified candidates shall be considered for exemption only after earmarking the vacancies equivalent to the number of qualified candidates available as on date and can be promoted within next one year in the Division. The remaining vacancies earmarked for qualified candidates shall be filled by unqualified candidates, where necessary."

2. After careful consideration, the AP TRANSCO issues the following amendment to Sub-para (ii) of para - 2 of T.O.O.(Addl.Secy.-Per) Ms.No.249 Dt.23.01.2009 as follows:

AMENDMENT

**The existing ratio of 4:1 between qualified and unqualified candidates shall be followed. The unqualified candidates shall be considered for exemption only after earmarking the vacancies equivalent to the number of qualified candidates available as on date in the Division. The remaining vacancies earmarked for qualified candidates shall be filled by unqualified candidates, where necessary.**

3. The other terms and conditions in the T.O.O.(Addl.Secy.-Per) Ms.No.249 Dt.23.01.2009 remain un-altered.
