ORDER:

Government of A.P. in G.O.Ms.No.102, Finance (Pension-I) Department, dated 24.05.2011 have adopted the Government of India orders issued in O.M.No.4/59/97-D, P&PW(D), Dt.14.07.1998 and O.M.No.4/38/2008-P&PW(D), Dt.19.01.2010 and ordered that the Government Employees absorbed in Public Sector Undertakings/Autonomous bodies who have retired are entitled for additional quantum of Pension to Pensioners on full pension and Dearness Relief thereon and also sanction of Family Pension on par with State Government Pensioners provided they do not draw family pension from any other source.

2. After careful consideration, Transmission Corporation of Andhra Pradesh Limited hereby adopts the orders issued by Government of A.P. in G.O.Ms.No.102, Finance (Pension-I) Department, dated 24.05.2011 (copy enclosed) and orders that the Employees absorbed in Public Sector Undertakings/Autonomous bodies and retired are entitled for additional quantum of Pension to Pensioners on full pension and Dearness Relief thereon as per orders issued in T.O.O. 7th cited. It is also ordered to sanction Family Pension to above absorbees on par with APTRANSCO Pensioners provided they do not draw family pension from any other source.

3. These orders shall come into force on par with State Government Pensioners.

4. These orders are issued with the concurrence of Director (Finance & Revenue) vide Regd.No.2237 Dt.14.06.2011.

PENSIONS – Extension of benefits of Family Pension and additional quantum of pension to the Employees absorbed in PSUs – Orders – Issued.

ORDER:

In the Government Order 1st read above, orders were issued that the benefit of restoration of 1/3rd of commuted portion of pension after a period of 15 years from the date of commutation is permissible for the Government employees who were absorbed in a Public Sector Undertakings/Autonomous Bodies, and have commuted or opted to commute 100% of their pension on absorption. The restored amount of one third commuted portion of pension is not be further enhanced to minimum pension fixed from time to time. However, they are eligible for consolidation of pension ordered from time to time.

2. In the Government Order 2nd read above, orders were also issued allowing the Dearness Relief, Interim relief and fitment benefit shall be calculated on full pension to the PSU absorbees while restoring 1/3 commuted pension. It was also ordered therein that the family members of these employees are not eligible for family pension as per A.P. Revised Pension Rules, 1980.

3. Representations have been received from the State Government employees absorbed in PSUs, requesting for sanction of family pension to them on par with the Central Government Employees who were absorbed in PSUs as they have not surrendered their right as pensioners but have commuted 100% pension as per rules because of their absorption in PSUs in public interest and the PSU absorbees are pensioners in all respects and their service in Government is a criterion for sanction of pension and family pension. They have also requested for extension of the benefit of additional quantum of pension sanctioned to the State Government employees vide G.O.Ms.No.100, Finance (Pen-I) Department, dated 6-4-2010, to them.

4. The Government of India have sanctioned family pension to the Central Government Employees who were absorbed in PSUs vide O.M. No. 4/59/97-D P & PW(D), dt 14-7-1998 in the reference 3rd read above (Annexure-I)

5. The Government of India have also issued Orders vide O.M. No.4/38/2008-P&PW (D) dt.19-01-2010 sanctioning the quantum of additional pension available to old pensioners and Dearness Relief thereon in respect of PSU absorbees on full pension in the reference 4th read above (Annexure-II).

6. Government, after careful consideration of the matter, decided to adopt the orders issued by the Government of India in the references 3rd and 4th read above in respect of Government employees absorbed in Public Sector Undertakings/Autonomous bodies. Accordingly, hereby order that the Government employees absorbed in Public Sector Undertakings/Autonomous bodies who have retired are entitled for additional quantum of pension to pensioners on full pension and Dearness relief thereon and also sanction of Family Pension on par with State Government pensioners provided they do not draw family pension from any other source.
