ORDER:

In the G.O. 4th cited, the Government of A.P. have issued orders revising the existing rates of Transfer Travelling Allowance to the Government Employees viz., Charges for the transport of Personal Effects, Packing/Loading and Unloading/Unpacking Charges, Disturbance Allowance or Lumpsum Travel Grant on transfer and Millege Allowance.

2. After careful consideration, the Transmission of Andhra Pradesh Limited hereby orders that the Government Orders issued in G.O.Ms.No.128, Finance (TA) Dept., Dt.17.04.2010 shall be made applicable to Employees working in APTRANSCO as per the Grades classified in the T.O.O.3rd cited as follows:

a) Grades of Officers:

The Classification of Officers into Grades shall be as indicated below:

Grade	Employees in the Revised scale of Pay, 2010
Grade-I	Rs.30600-1280-37000-1430-44150-1585-45735 and above
Grade-II	Rs.19450-800-20250-955-25025- 1115-30600-1280- 31880 and above
Grade-III	Rest of the employees

b) Charges for the transport of personal effects:

The Employees are allowed to the actual charges spent by the Employee for the transport of personal effects subject to the following maximum amount admissible as per the Grade to which the employee belongs. These charges may be allowed irrespective of the mode of transport of personal effects between the two places either fully connected by rail, or fully not connected by rail but fully connected by road, or partly connected by rail and partly connected by road.

Grade	Maximum weight Permissible	Rate
Grade - I	5000 Kgs.	@ Rs.0.003 per kg/per k.m, subject to a maximum of Rs.15/- per k.m
Grade - II	4000 Kgs.	@ Rs.0.003 per kg/per km, subject to a maximum of Rs.12/- per k.m
Grade - III	3000 Kgs.	@ Rs.0.003 per kg/per k.m, subject to a maximum of Rs.9/- per k.m

c) Packing/Loading and Unloading/unpacking charges:

In addition to the payment of charges towards the cost of transport of personal effects, APTRANSCO Employees are allowed actual charges towards packing/loading and unloading/unpacking of personal effects subject to the following maximum limits in view of the general increase of charges.

d) Disturbance Allowance or Lumpsum Travel Grant on transfer:

In case of transfer of an Employee from any place within the State to Delhi and any other place outside the State and also in the case of transfer from Delhi and places outside the State to any place within the State, the APTRANSCO Employees are eligible for Disturbance Allowance or lumpsum Travel Grant for each transfer at the following rates.

Grade	Revised Rate
Grade-I	Rs.10,000/- (However, employees drawing pay in the scale of pay of Rs.39,860/- or above, shall be allowed Rs.12,000/- for carrying Personal effects by road)
Grade-II	Rs. 7,500/-
Grade-III	Rs. 5,000/-

e) Mileage Allowance:

In case when a journey between the places not connected either by railway or by a regular public motor service, is performed the employees are eligible for mileage allowance at the rates indicated below provided the place visited is situated outside a radius of 8 k.m. from headquarters or from one camp place to another camp place.

Grade	Revised Rate
Grade-I	Rs.6/- per K.M
Grade-II	Rs.4.50 per K.M
Grade-III	Rs.4/- per K.M

3. The claims for transport of Personal effects as per revised rates shall be allowed as per the rules laid down in B.P.(P&G-Per) Ms.No.52, Dt.11.05.1992.
4. The existing Andhra Pradesh Civil Service (Travelling Allowance) Rules and orders issued from time to time by Government of A.P. as adopted by APTRANSCO shall continue to apply except as provided for in this order.
5. These orders shall come into force with effect from 13.08.2010 i.e. for the journeys performed on or after 13.08.2010.
6. The journeys performed before issue of these orders which are not preferred for claims, shall be admitted in terms of orders issued in T.O.O.(Addl.Secy.-Per) Ms.No.235, dt.10-01-2006.
7. These orders are issued with the concurrence of Director (Finance & Revenue) vide Regd.No. 2807, Dt.09.08.2010.
