ORDER:-

A.P.Transco in Memo 1st cited have issued clarification orders to SE/TL&SS/Hyderabad Zone that payment of 20% of pay at minimum of ordinary grade scale of pay as Generation Allowance and difficult area allowance shall be continued to the Divisional Engineer/EHT Lines & Sub-Station staff as per B.P. (P&G-Per) Ms.No.258, dt.08-01-1999 as long as they are working in Nagarjunsagar

2. A.P.Transco in Memo. 2nd cited have issued clarification orders to CE/TL&SS/Kadapa that Generation/Difficult Area Allowance shall be paid to all the similarly placed employees @ 25% of pay at minimum of the ordinary scale as per the orders issued vide T.O.O.(Joint Secretary-Per) Ms.No.74, dt.07-06-2006.

3. The Employees Associations have made several representations requesting for sanction of Project Allowance to all Employees of APTRANSCO working at APGENCO Power Generating Plants on par with APGENCO Employees at revised rates applicable at the respective APGENCO Power Generating Plants.

4. After careful consideration, Transmission Corporation of Andhra Pradesh Limited hereby orders that the Employees who are working in areas located at APGENCO Power Generating Plants shall be paid Project Allowance in lieu of Difficult Area Allowance/Generation Allowance in Revised Pay Scales, 2010 as is being paid to APGENCO Employees as per rates given hereunder.

Description	Rate
Thermal stations & Gas Generating Stations Plants	30% on Minimum of Ordinary Grade Scale
Hydel Plants (Except Sileru Complex) including Mini Hydels & TBHES Plants	33% on Minimum of Ordinary Grade Scale
Sileru Complex including Machkund Hydel Generating Stations and Talcher Plants	50% on Minimum of Ordinary Grade Scale

5. The Project Allowance shall be payable to the said Employees subject to the following conditions: -

- a) In case of work-to-rule and strike, specific orders of APTRANSCO as the case may be obtained on each occasion for admissibility of Project Allowance.
- b) In case where the Employees proceed on leave other than casual leave, allowance is not admissible for the leave period only but proportionate amount may be paid for the duty period.

6. All Chief Engineers/Superintending Engineers/Divisional Engineers/ Executive Engineers and other pay drawing officers concerned are responsible for identification of the personnel coming under the purview of these orders and accordingly Project Allowance may be paid. If any deviations are noticed in future regarding implementation of these orders, it shall be viewed very seriously and disciplinary action shall be initiated against the concerned.

7. These orders shall come into force with effect from 01-04-2010.

8. These orders are issued with the concurrence of Director (Finance & Revenue) vide Regd.No. 3010, Dt.24-08-200.
