ORDER:

The Employees Unions have requested to examine the following issue for implementation of AP Revised Pension Rules, 1980 and GPF Regulations to the employees appointed and joined after 01.02.1999.

Sl. No.	Demand
1	Implementation of GPF scheme and Revised Pension Rules of A.P. to the employees appointed after 01.02.1999 also as there shall not be two schemes in one industry.
2	Extension of pensionary benefits to the employees appointed on or after 01.02.99 and up to 31.08.2004 as the Government of AP introduced contributory pension scheme to its employees w.e.f. 01.09.2004 in as much as the Electricity Industry has adopted Government pension Rules and continue to adopt changes therefor.

2) In the reference first cited, the Government of AP, Energy Department has been requested to advise on the above issue. In the reference 2nd cited, the Additional Secretary to Government Energy Department, Hyderabad has requested to form a Board level sub-committee to examine the above demands along with any other similar demands if made and they may be asked to submit their report to the Board and then furnish detailed report along with necessary enclosures to Government for taking a decision in the matter

3) After careful consideration, the APTRANSCO hereby constitutes a Committee with the following officers to examine the above issue raised by the Employees Unions for (i) Implementation of AP Revised Pension Rules, 1980 and GPF Regulations to the employees appointed and joined after 1.2.1999 and (ii) Extension of pensionary benefits to the employees appointed on or after 01.02.1999 and upto 31.08.2004.
