**ORDER:**

APTRANSCO in T.O.O. 1<sup>st</sup> cited have issued orders granting relaxation of qualification of I.T.I. to the post of Junior Lineman for the appointments made under compassionate appointment subject to the following conditions:

- i) Dependent of deceased employee who has possessed S.S.C. Qualification shall be considered for appointment to the post of Junior Lineman subject to the condition that the candidate shall acquire I.T.I. qualification within four (4) years from the date of compassionate appointment. If the candidate fails to acquire the qualification within the prescribed time limit the commencement of probation shall be postponed till such time the said qualification is acquired.
  - ii) The appointments to the post of Junior Lineman under compassionate appointment shall be considered subject to fulfilling all other conditions stipulated from time to time.
2. APTRANSCO in T.O.O 2<sup>nd</sup> cited, have issued orders relaxing qualification of I.T.I to the post of Junior Lineman to the dependents of employees who retired on Medical Invalidation by extending the orders issued in T.O.O.(Addl.Secy.-Per) Ms.No.226, dt.17-12-2008.
3. The Employees Unions have requested to relax the condition of acquiring I.T.I qualification within four years from the date of appointment to the post of Junior Lineman under compassionate grounds and appointment by transfer as there is no provision to appear I.T.I in part time in the institutions unless the candidate possess practical experience of five years and requested to restore the orders issued in Memo. dated 09-10-1992 and Memo. dated 20-05-1997 on the subject matter.
4. The subject matter has been discussed in APPCC Meeting held on 08.07.2010 and a consensus decision was taken to prescribe seven years time limit in lieu of existing four years time limit for acquiring I.T.I Qualification from the date of appointment to the post of Jr. Lineman in respect of compassionate appointments including medical invalidation and appointment by transfer from the categories of Office Sub-Ordinate, Watchman and Sweeper-cum-Gardner subject to the existing conditions.

5. After careful consideration, Transmission Corporation of Andhra Pradesh Limited hereby issues the following amendment to T.O.O.(Addl.Secy.-Per) Ms.No.226, Dt.17-12-2008.

AMENDMENT

The Words "four (4) years" occurring in clause (i) of para 7 of said T.O.O. shall be read as "seven (7) years".

6. All other conditions mentioned in T.O.O.(Addl.Secy.-Per) Ms.No.226, Dt.17-12-2008 shall remain unaltered/unchanged.
