ORDER

In the reference 1st cited, Law (L2) Department, Government of Andhra Pradesh have reiterated that entrustment of routine cases to private advocates bypassing the Government Law Officers affects their moral, apart from resulting in avoidable extra expenditure that which needs to be granted for and directed to ensure that court cases including the contempt cases are entrusted to the Government Pleaders and Standing Counsel concerned. It is further instructed that important and complicated cases may be entrusted to the learned Advocate General by obtaining prior permission of the Government and Senior Advocates / Special Counsel may be engaged in specific cases after obtaining prior orders of Government.

APTRANSCO after careful consideration, hereby adopts the instructions issued by Govt. of A.P. in Circular Memo.No.500/LSP/173/L.2/2010, Law (L2) Department, Dt.04-11-2010 and directs all the functional heads / HODs to adhere to the instructions issued in the Circular (copy enclosed) without fail.
