In T.O.O 2<sup>nd</sup> cited, APTRANSCO has issued orders adopting the Government rates of Traveling allowance on tour admissible to the employees of APTRANSCO duly following the Grades ordered in T.O.O 1<sup>st</sup> cited.

2) In the T.O.O 3<sup>rd</sup> cited, orders were issued revising the grades and eligibility to Travel by the employees on Tour, consequent on revision of Pay Scales, 2006.

3) In the T.O.O 4<sup>th</sup> and 5<sup>th</sup> cited, Scales of Pay of the employees of both “Workmen” and “Other than Workmen” were revised with effect from 1-4-2010.

4) Consequent on the revision of the Pay Scales, 2010, the classification of grades are hereby revised as mentioned hereunder:

<b>Grade</b>	<b>Employees in the Revised Scale of Pay 2010</b>
Grade-I	Rs.30600-1280-37000-1430-44150-1585-45735 and above
Grade-II	Rs.19450-800-20250-955-25025-1115-30600-1280-31880 and above
Grade-III	Rest of the employees

(a) The employees of APTRANSCO drawing pay in revised Scales of pay of Rs.39860-1430-44150-1585-52075 and above may travel by Air-conditioned First Class for the journey by train

(b) The employees of APTRANSCO drawing pay of Rs.23,115/- and above in the revised pay scales 2010 shall be eligible to travel by 1<sup>st</sup> class.

(c) All other employees shall be eligible to travel by IInd class

Note: “Officers eligible to travel by 1<sup>st</sup> class may travel either in 1<sup>st</sup> class or in 2<sup>nd</sup> A.C. or in 3<sup>rd</sup> A.C or in A.C. Chair car. If there is no first class in the train the employee may travel either in 2<sup>nd</sup> A.C or in 3<sup>rd</sup> A.C or in A.C. Chair Car.”

“The employees who are eligible to travel by second class may also travel by sleeper class.”
