APTRANSCO - Sanction of Additional Quantum of Pension to Service Pensioners/ Family Pensioners - Adoption of Government Orders - Orders - Issued.

ORDER:-

APTRANSCO in T.O.O. cited have issued orders consolidating pension to the Pensioners who retired/died while in service before 01.04.2010 duly merging Dearness Relief as on 01.01.2010 and adding 30% of basic pension to the existing pension w.e.f. 01.04.2010. It was also ordered therein that a sum of Rs.250/- pm shall be paid as Medical Allowance to the Pensioners w.e.f. 01.04.2010 subject to the conditions specified therein.

2. The Retired Employees Associations/Individuals have requested to sanction additional quantum of Pension to Service Pensioners/Family Pensioners who have attained the age of 75 years and above on par with State Government Pensioners/Family Pensioners as ordered in G.O.Ms.No.100, Finance (Pension-I) Dept., Dt.06.04.2010.

3. Govt. of A.P. in G.O.Ms.No.100, Finance (Pension-I) Dept., Dt.06.04.2010 have issued orders revising the Pension of the Service Pensioners/Family Pensioners to those who retired or died while in service prior to 01.07.2008 with effect from 01.07.2008 notionally with monetary benefit from 01.02.2010. It was also ordered therein to allow additional quantum of pension/family pension to those pensioners/family pensioners on attaining the age of 75 years and above as indicated in the table mentioned therein.

4. The issue regarding sanction of Additional Quantum of Pension to Service Pensioners/Family Pensioners of APTRANSCO on par with Pensioners of Government of A.P. as sanctioned in G.O.Ms.No.100, Finance (Pension-I) Dept., Dt.06.04.2010 was discussed in detail in APPCC Meeting held on 26.10.2010 and a consensus decision was taken to adopt Government Orders.

5. After careful consideration, Transmission Corporation of Andhra Pradesh Limited hereby adopts Government Orders issued in G.O.Ms.No.100, Finance (Pension-I) Dept., Dt.06.04.2010 and hereby orders for sanction of Additional Quantum of Pension to APTRANSCO Service Pensioners/Family Pensioners on attaining the age of 75 years and above as indicated in the table hereunder.

Sl.No.	Age of Pensioners	Additional Quantum of Pension
1)	From 75 years to less than 80 years	15% of basic pension
2)	From 80 years to less than 85 years	20% of basic pension
3)	From 85 years to less than 90 years	25% of basic pension
4)	From 90 years to less than 95 years	30% of basic pension
5)	From 95 years to less than 100 years	35% of basic pension
6)	100 years or more	50% of basic pension

6. The following working instructions are issued for calculating Additional Quantum of Pension to Service Pensioners/Family Pensioners as sanctioned in para 5 above.

- a) Additional Quantum of Pension as sanctioned above has to be worked out on the Revised Consolidated Basic Pension/Revised Consolidated Basic Family Pension as sanctioned in T.O.O.(Addl.Secy-Per) Ms.No.26, Dt.21.04.2010 with effect from 01-04-2010 and monetary benefit shall be allowed with effect from 01-04-2010.
- b) The amount of Additional Quantum of Pension has to be shown distinctly in the Pension Payment Order. The said pension on attaining the age of 75 years and above has to be admissible from the 1<sup>st</sup> day of the month in which his/her date of birth falls.
- c) The Dearness Relief admissible shall be allowed on the quantum of Additional Pension also from time to time.

7. These orders shall come into force with effect from 01-04-2010 with monetary benefit from 01-04-2010

8. These orders are issued with concurrence of Director (Finance & Revenue) vide Regd.No.3891, Dt.29.10.2010.
