**ORDER:-**

APTRANSCO in T.O.O. 1<sup>st</sup> cited have issued orders revising Pay Scales to its Employees who are coming under the category of Workmen with effect from 01.04.2010.

2. APTRANSCO in T.O.O.2<sup>nd</sup> cited have issued orders that the Government Orders regarding Principles of Fixation of Pay in RPS, 2010 to the Employees who are leave on date of implementation of RPS, 2010 shall be made applicable to APTRANSCO Employees.

3. After careful consideration, Transmission Corporation of Andhra Pradesh Limited hereby issues the following amendment to T.O.O.(CGM-HRD&Trg) Ms.No.14, Dt.15.04.2010

**AMENDMENT**

The existing Para 5 (d) of Appendix-I to T.O.O.(CGM-HRD&Trg) Ms.No.14, Dt.15.04.2010 shall be renumbered as 5(d)(i) and shall be read as follows:

" An Employee who is under suspension on the 1<sup>st</sup> April 2010 shall be entitled to have his pay fixed in accordance with these principles subject to the condition that the monetary benefit shall accrue to him only from the date of resumption of duty by him or date of option whichever is later. A discharged employee shall enter the Revised Pay Scales 2010 only from the date of his joining appointment"

The following shall be added as para 5(d)(ii) after para 5(d)(i).

" An Employee who is on leave without leave salary on 01.04.2010, is entitled to get the pay fixed with effect from the date of entry into the Revised Pay Scales, 2010 and he shall be entitled for monetary benefit from the date of assumption of duty or 01.04.2010 whichever is later"

4. These orders shall come into force with effect from 01.04.2010 with monetary benefit from 01.04.2010.

5. The other principles/conditions mentioned in T.O.O.(CGM-HRD&Trg) Ms.No.14, Dt.15.04.2010 remains unaltered/unchanged.
