In the G.O. 3rd read above, the Government of Andhra Pradesh appointed Sri P.Laxma Reddy, Advocate as Standing Legal Counsel for APTRANSCO in the Hon'ble High Court of AP for a period of 3 (three) years from the date of assumption of charge. It was also ordered therein that the conditions of service shall be in accordance with the instructions issued in the reference 1st read above as amended from time to time. Accordingly Sri.P.Laxma Reddy,Advocate gave his consent letter to take charge vide reference 4th cited.

2. After careful consideration, the APTRANSCO hereby adopts the orders issued in G.O.Rt.No.1748, Law Department, Dt.26-10-2010, vide reference 3rd read above.

3. Consequent upon his appointment as Standing Legal Advisor to APTRANSCO, Sri P.Laxma Reddy, Advocate is required to appear on behalf of APTRANSCO in the Hon'ble High Court of A.P. His engagement is subject to the regulations governing appointment and payment of fee to Standing Legal Advisors and other legal counsels issued vide T.O.O.Ms.No.92, Dt.04-08-2005 and also subject to the amendments ordered to the aforesaid regulations from time to time apart from the service conditions stipulated in the G.O 1st read above.

4. Sri P.Laxma Reddy, SLA shall enter appearance in the Court cases as per the work allocation indicated below:

- (i) All Writ Petitions filed against APTRANSCO and Writ Appeals filed against judgments in Writ Petitions on all **Service Matters and Labour Matters**.
- (ii) He is required to tender advice on matters referred to him by various Officers of the APTRANSCO for legal opinion.
- (iii) He is required to transfer any brief to any other Advocates if the APTRANSCO so desires, without any objection to safeguard the interest of APTRANSCO.
- (iv) He is required to inform daily about the new cases filed against the APTRANSCO, the cases heard and disposed of during the day, where judgments were delivered, the details of judgments along with his opinion whether there are any good grounds to file an appeal or not or any other important information to be conveyed to APTRANSCO, so as to ensure follow up action promptly.

The APTRANSCO reserves its right to engage any other Advocate in any specific case/s filed either before the Hon'ble High Court or any other Court or Tribunal depending on the nature and stakes involved in a case and the specialization possessed by such Advocate in the subject relating to such case/s.
