ORDER:

2. Consequent on assumption of charge of Sri.P.Ramesh, IAS as Joint Managing Director(Comml., IPC & IT)/APTRANSCO, the additional charge held by Sri Umesh Sharraf, IPS, JMD (V&S) for the post of JMD(Comml., IPC & IT) has been terminated w.e.f. 16.05.2011 AN.

3. In the reference 5th cited, it has been requested to arrange to pay the additional charge allowance for the period from 21-01-2011 FN to 16-05-2011 AN for the post of JMD (Comml.,IPC & IT).

After careful examination of the issue and as per note 2 (2) under Regulation 54 of APSEB Service Regulations Part-I as adopted by AP Transco, sanction is hereby accorded to Sri Umesh Sharraf, IPS, JMD (Vigilance & Security)/AP Transco for drawal of full additional charge pay at the rate of 1/5th of his pay or ½ of the minimum pay of the additional post whichever is less for the first three months and thereafter 1/10th of his pay or 1/4th of the minimum pay of the additional post which ever is less for the period beyond three months from 21-01-2011 FN to 16-05-2011 AN.
