ORDER:

Consequent on proceeding of Ex-India Earned Leave of Sri.K.Rangantham, JMD (HRD & Distribution) in the reference 1st cited, Sri P.Ramesh, IAS, JMD(Commercial, IPC & IT)/AP Transco was authorized to hold full Additional Charge of the post of JMD (HRD & Dist.)/ AP Transco in addition to the post of JMD(Commercial, IPC & IT)/ AP Transco. Accordingly, he had assumed charge of the above post on 29.06.2011 FN.

2. On return from Ex-India Earned Leave and assumption of charge of Sri.K.Rangantham, as Joint Managing Director(HRD & Distribution)/APTRANSCO, the additional charge held by Sri P.Ramesh, IAS, JMD(Commercial, IPC & IT) for the post of JMD(HRD & Distribution) has been terminated w.e.f. 31.07.2011 FN.

3. In the reference 3rd cited, it has been requested to arrange to pay the additional charge allowance for the period from 29.06.2011 FN to 30.07.2011 AN for the post of JMD (HRD & Distribution).

After careful examination of the issue and as per note 2 (2) under Regulation 54 of APSEB Service Regulations Part-I as adopted by AP Transco, sanction is hereby accorded to Sri P.Ramesh, IAS JMD(Commercial, IPC & IT)/AP Transco for drawal of full additional charge pay at the rate of 1/5th of his pay or 1/2 of the minimum pay of the additional post whichever is less for the first three months and thereafter 1/10th of his pay or 1/4th of the minimum pay of the additional post which ever is less for the period from 29.06.2011 FN to 30.07.2011 AN.
