ORDER:

In the references 3<sup>rd</sup> to 5<sup>th</sup> cited, orders were issued for payment of basic wages along with the Variable Dearness Allowances payable to the above contract labour from 01.04.2012 to 31.03.2013.

2. In the reference 6<sup>th</sup> cited the Commissioner of Labour, Labour Department, Government of A.P. has furnished the variable dearness allowance applicable to the contract labour with effect from 01.04.2013 as per the Minimum Wages Act, 1948 as detailed therein.

After careful consideration, Transmission Corporation of Andhra Pradesh Limited hereby accords approval for payment of Variable Dearness Allowance (Cost of living allowance) to Highly Skilled, Skilled & Un-Skilled labour working on contract basis in O&M of EHT Sub-Stations & Lines of APTRANSCO with effect from 01.04.2013 as detailed below:
