### PROCEEDINGS:

The APTRANSCO accorded approval vide references cited for supply, erection, testing & commissioning of 32Nos. new capacitor banks at respective EHT sub-stations and the Chief Engineer/Transmission shall float open tenders and works will be taken through TLC wing of respective zone.

After further discussions, it was decided that the Chief Engineer/Lift Irrigation shall initiate procurement of above capacitor banks since procurement/tendering activities are not being dealt by the CE/Transmission wing.

Hence, the APTRANSCO accords approval for supply, erection, testing & commissioning of 32Nos. new capacitor banks at respective EHT sub-stations with the following instead of floating tenders by CE/Transmission:

- i) To furnish indent to CE/Lift Irrigation for procurement of required 32Nos. new capacitor banks, NCTs and structures along with associated equipments like series reactors, Circuit breakers, isolators, CTs, LAs & C&R panels, etc.
- ii) To authorize the Chief Engineer/zone concerned to execute the erection and commissioning of 32Nos.new capacitor banks at respective EHT sub-stations on receipt of equipment under capital head.

The number of sub-stations indicated in Annexure enclosed with the T.O.O.s in references (1) to (3) cited and all other terms and conditions remain unaltered.
