Vide reference 1<sup>st</sup> cited, the Superintending Engineer / TLC Circle/ Karimnagar has informed that the administrative approval was accorded for erection of 132/33 KV Sub-station at Kachapur Village vide T.O.O (CE- Construction-I) Ms.No.310, dt:15.01.2013 to reduce the overload on 33 KV feeders and 33 KV Sub-stations and to improve voltage conditions and quality and reliability of power supply for which an extent of 4 acres of Govt. land in Sy.No.234 in Kachapur (V) is identified. The market value of the proposed land is Rs.2,00,000/- per acre (total market value worked out to Rs.8,00,000/-).

In the reference 2<sup>nd</sup> cited, the Chief Engineer, Construction-I has informed that the District Collector, Karimnagar in his letter dt:1.4.2013 issued orders for alienation of 4 acres of land in Sy.No.234 of Kachapur (V) Shankarapatnam (M) in favour of Executive Engineer/ TLC/ Karimnagar as per new Government land allotment policy vide G.O.Ms.No.571, dt:14.09.2012.

The Superintending Engineer/ TLC Circle/ Karimnagar and the Chief Engineer/ Construction-I have requested for approval for payment of Rs.8,00,000/- to the Tahasildar, Shankarapatnam (M) in Karimnagar District towards cost of 4 acres of land in Sy.No.234 as directed by the District Collector, Karimnagar for handing over of the possession of the land for construction of 132/33 KV Sub-station at Kachapur.

After careful consideration of the above proposal, the Transmission Corporation of A.P. Limited accords approval to the Superintending Engineer/ TLC Circle/ Karimnagar for depositing an amount of Rs.8,00,000/- with the Tahasildar, Shankarapatnam (M) in Karimnagar District towards cost of 4 acres of land in Sy.No.234 for the construction of 132/33 KV Sub-station at Kachapur.
