**ORDER:**

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P Transco, Sri S.Thirupathi Reddy, Junior Accounts Officer is promoted temporarily to act as Assistant Accounts Officer with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is also as per Rule of Reservation in promotion in favour of S.Cs & S.Ts as adopted by A.P Transco.

4. The promotion ordered in para-1 above is subject to result of appeals filed by the Retired officers of the erstwhile APSE Board against the judgement in W.P Nos.2360-91/83 and pending in the Hon'ble Supreme Court of India and also subject to the result of WP.No. 24684/09 pending in the Hon'ble High Court of A.P.

5. Sri S.Thirupathi Reddy, Junior Accounts Officer, O/o.SAO/GPF/APTRANSCO/VS/Hyd on temporary promotion as Asst. Accounts Officer and **FOUR** existing AAOs are transferred and posted to the places noted against their names mentioned in the Annexure appended to this order.

6. The concerned controlling officer is requested to relieve the above Junior Accounts Officer by making local arrangement pending posting of substitute to enable him to assume charge on promotion as AAO at the place of posting ordered above.

7. The promotee is directed to assume charge on promotion as Asst. Accounts Officer at the place of posting ordered, after obtaining proper relief from the present place of working.

8. The Asst. Accounts Officers transferred are also directed to assume charge at the place of posting now ordered after obtaining proper relief from the present place of working.

9. The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly within 15 days from the date of receipt of the order, failing which he has to forego all the rights both present and in future for such higher post. If he fails to join duty within the time limit or evades to join duty, such period till he re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON' He shall also be liable for disciplinary action.

10. The date of joining of the candidate on promotion as Asst. Accounts Officer will be reckoned as date of commencement of probation.


