ORDER:

Under Regulation 14 (a) (1) of A.P.S.E.Board S.Rs - Part-II, as adopted by A.P TRANSCO, Sri C. Ram Prasad, Divisional Engineer/Telecom is promoted temporarily to act as Superintending Engineer/Telecom with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is without prejudice to the seniority of the officers that will emerge after review of the F.C.G List of Assistant Engineers of Electricity Department as on 1-11-1956 is finalized. It is also subject to result of Writ Appeal filed by the retired officers of erstwhile A.P.S.E. Board against the judgment in W.P.No. 2360-91/1983 and pending in the Hon'ble Supreme Court.

4. The Promotion ordered in para-1 above is also subject to the final outcome of W.P.No.2536 of 2004 and W.P.No.10358 of 2009 filed by Sri G.Abraham, DE/Telecom and W.P.No.25037 of 2006 filed by Sri J.Raghupathi & others pending in the Hon'ble High Court of A.P.

5. Sri C. Ram Prasad, DE/Telecom/LD/Metro/Hyderabad on temporary promotion as Superintending Engineer/Telecom as ordered above is transferred and posted as Superintending Engineer/Telecom/ Warangal in the existing vacancy.

6. The concerned Controlling Officer is requested to relieve the above promotee by making local arrangement pending posting of substitute to enable him to assume charge at the place of posting ordered above.

7. The promotee is requested to assume charge at the place of posting ordered after obtaining proper relief from the present place of working.

8. The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly after obtaining proper relief from the present place of working within 15 days from the date of receipt of these orders, failing which he has to forego all the rights both at present and in future for such higher post. If he fails to join duty within the time limit or evades to join duty by proceeding on leave such period will be treated as un-authorized absence besides treating such period of un-authorized absence as 'DIES-NON'. He shall also be liable for disciplinary action.
