ORDER:

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P TRANSCO, Sri U. Narsimulu, Asst. Divisional Engineer/Telecom is promoted temporarily to act as Divisional Engineer/Telecom with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotion ordered in para-1 above is without prejudice to the seniority of the officers that will emerge after review of the F.C.G List of Assistant Engineers of Electricity Department as on 1-11-1956 is finalized.
4. The promotion ordered is subject to result of Writ Appeal filed by the retired officers of erstwhile A.P.S.E. Board against the judgement in W.P.No.2360-91/1983 and pending in the Hon'ble Supreme Court. The promotion is also subject to result of Writ Petitions pending in the Hon'ble High Court of A.P., regarding seniority.
5. Sri U. Narsimulu, ADE/Telecom/Shift/VS/Hyd on temporary promotion as Divisional Engineer/Telecom as ordered above is transferred and posted as DE/Telecom/LD/Metro/Hyderabad in the existing vacancy.
6. The concerned Controlling Officer is requested to relieve the above promotee by making local arrangements pending posting of substitute to enable him to assume charge on promotion as DE/Telecom at the place of posting ordered.
7. The promotee is directed to assume charge on promotion at the place of posting ordered, after obtaining proper relief from the present place of working.
8. The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly after obtaining proper relief from the present place of working within 15 days from the date of receipt of this order, failing which he has to forego all the rights both present and future for such higher post. If he fails to join duty within the time limit or evades to join duty such period till he re-joins will be treated as un-authorised absence besides treating such period of un-authorised absence as 'DIES-NON'. He shall also be liable for disciplinary action.
