ORDER:

In the reference 1st cited, orders were issued for sanction of an amount of Rs.1,95,500/- (Rupees One Lakh Ninety Five Thousand and Five Hundred only) towards medical coverage premium including Service Tax @12.36%, for payment of annual premium to M/s National Insurance Company Limited, Secunderabad for renewal of the Group Personal Accident Insurance Cover of Rs.15,00,000/- (Rupees Fifteen Lakhs) each or 72 times of the gross pay of the each individual, whichever is less, for the existing 92 Nos. (Ninety Two) Hot Line Trained Staff working in Hotlines Wing of APTRANSCO for the period from 10.09.2012 to 09.09.2013.

2. In the reference 2nd cited, the Chief Engineer/Power Systems has stated that the existing Group Personal Accident Insurance Cover with M/s National Insurance Company Limited, Secunderabad referred to at para(1) above is being expired on 09.09.2013 and proposed to renew the coverage of above said Insurance Policy of Rs.15,00,000/- to each of the Hot Lines Trained Staff (92 Nos.) working in Hotlines Wing of APTRANSCO for a further period of one year from 10.09.2013 to 09.09.2014 by sanctioning an amount of Rs.1,95,500/-.

3. After careful examination of the proposal of Chief Engineer/Power Systems/Vidyut Soudha, Hyderabad, the APTRANSCO hereby accords approval for sanction of an amount of Rs.1,95,500/- (Rupees One Lakh Ninety Five Thousand and Five Hundred only) towards Medical Coverage Premium including Service Tax @ 12.36%, for payment of annual premium to M/s. National Insurance Company Limited, Secunderabad for renewal of the Group Personal Accident Insurance Cover of Rs.15,00,000/- (Rupees Fifteen Lakhs) each or 72 times of the gross pay of the each individual, whichever is less, for the existing 92 Nos. (Ninety Two) Hotline Trained Staff working in Hotlines wing of APTRANSCO for the period from 10.09.2013 to 09.09.2014.

4. The amount sanctioned in para(3) above is subject to the Budget Provision to be made by the Chief Engineer/Transmission, Vidyut Soudha, Hyderabad.

5. The Chief Engineer/Power Systems is requested to take necessary action for payment of insurance premium sanctioned above, and get the insurance covered for the sum assured to all the employees working in Hot Lines and further requested to extend this Group Personal Accident Insurance cover for the Hotlines trained persons joining the Hotlines wing in future.
