- 4. The SSHMI application facilitates the following
 - a. Digitization of Substation records such as Logs, Hourly Readings and Line Clear operations etc.
 - b. Access to the respective Higher Officials remotely in secured manner.
 - c. Instant communication of Substation Logs & Events through the application to the higher officials.
 - d. Application Integrated with SAP ERP.

- It is directed that all the Engineers shall be maintained the Logs and Hourly Readings and Line clear Operations etc through the SSHMI Application with effect from the Date of these orders.
