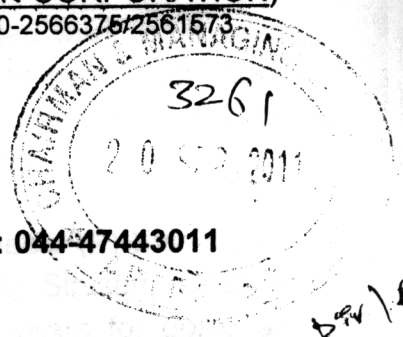

1. W.O. No. 820/F-120A/Vol.-I dated 12/03/2010 was placed on your firm for complete Operation & Maintenance of Coal Handling Plant-II & III for Units 5 to 8 of PTPS, HPGCL, Panipat at your revised rates of Rs. 11,15,00,000/- per annum inclusive of all taxes as applicable for a period of one year from: 01/04/2010 (Night Shift) to 31/03/2011 (Evening Shift) and extendable for another one year on the same rates and terms & conditions.

2. As per clause no. 28 of "General terms & conditions" appended to work order, demurrage charges to the extent as stipulated was recoverable from your monthly bill/security.

3. Since the amount of demurrage charges recoverable from your firm exceeded the amount of your bills, thus no payment was due. But still HPGCL released Rs. 25 Lakh in addition to the payment made to other agencies through whom services were hired by HPGCL on your request as your firm could not do the same. The said amount is recovered from you.


4. Your firm gave a notice of 7 days vide letter dated 30/10/2010 for stopping the work in response to which this office vide memo no. 1672 dated 04/11/2010 asked to continue the work but your firm left the work on 08/11/2010. It is brought out that there was no provision in the contract, under which your firm can stop the work by giving 7 days notice within the validity of the contract.

5. Despite specific request by this office to continue the work being of emergent nature to your firm, the work was not continued & HPGCL had to make arrangements in emergency at your risk & cost till 31/03/2010 from other agencies. This was the case of breach of contract on your part which was intimated to you vide this office memo no. 1676/CHP-II dated 11/11/2010.

6. A final notice was given vide memo dated 14/02/2011 as to why your firm should not be black listed for any future business relations with HPGCL.

7. The replies given by the firm against various references were not found satisfactory.
8. Your firm failed to execute the job against subject cited work order which tantamount to breach of contract. It has been decided by the competent authority to blacklist your firm for a period of three years for doing any business with HPGCL from the date of issue of this letter.
9. In view of above, your firm namely M/s Tecpro Engineers (P) Ltd. Tecpro Tower, 11-A17, 5<sup>th</sup> Cross Road, SIPCOT, I.T.Park, Siruseri, Chennai-603103 is hereby blacklisted for a period of three years for doing any business with HPGCL from the date of issue of this letter.

This is, however, without prejudice of other rights of HPGCL.


