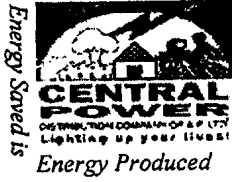

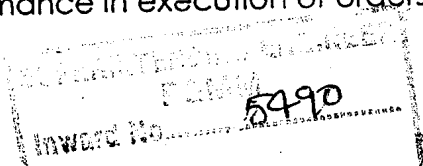

Purchase order has been placed on you vide reference cited above for supply of 125 Nos. of LT Distribution Boxes (SMC). As per clause 4 "Delivery" of the Purchase Order, you have to complete the supply of material within two months of purchase order i.e., by 13-12-2009.

But, till date you have not offered the material for inspection. However, you have submitted the 10% Bank Guarantee towards performance security of Rs. 59,731/- valid upto 01-12-2014. Non supply of LT Distribution Boxes (SMC) has resulted in delay in completion of the programmed and targeted works, causing much inconvenience and loss to APCPDCL.

In view of the above, the Purchase Order No. PM-2812/09, Dt.13-10-2009 for 125 Nos. of LT Distribution Boxes (SMC) is cancelled herewith. Your firm is barred to participate in CPDCL tenders for a period of 5 years besides intimating your poor performance in execution of orders to other discoms.
