Purchase Order no.CE/W&P/EZ/ACE(P)/EE(P)-I/ORD/1086 dtd.08.06.2011 was placed on you for supply of 290 nos. 11/0.433 KV, 100KVA Distribution Transformers against Tender Specification no.DISCOM/EZ/PUR/330 opened on 28.4.11 at your own quoted rates.

As per Clause-6 (Delivery) of the aforesaid order dtd.08.06.2011, you had to commence supply of 100KVA DTRs within one month from the date of issue of the order i.e. 15.7.11 and thereafter supply of 100% of ordered quantity was to be completed in four equal monthly installments i.e. upto 15.11.11.

As per Clause-3 (Security Deposit)", you had to complete contractual formalities by furnishing Security Deposit of Rs.19,83,600/- within 30 days from the date of the order in shape of Cash/Bank Draft/Bank guarantee from scheduled Bank.

However, even after lapse of considerable period, you have neither completed contractual formalities nor commenced supply for which protracted correspondence was made by this office vide letters dtd.23.07.11, 23.08.11, 03.11.11 & 28.11.11. Instead of completing formalities & offering the material you demanded deviation from contractual terms and conditions without furnishing any documentary evidences regarding completion of contractual formalities.

You had been given opportunities to explain as to why the action as per provisions of the contract may not be taken against your firm. You were advised to furnish your clarification in person or to depute authorized representative to explain the case in person too. But you have failed to do so.


Therefore, the matter has been considered by the competent authority of the Company and the following has been decided:-

CE/W&P/EZ/ACE(P)/EE(P)-I/ORD/1086 dtd.08.06.2011 is hereby cancelled for entire ordered quantity of 290 nos. 100KVA DTRs with recovery of Rs. 19,48,800/- (Rupees Nineteen Lakh forty eight thousand eight hundred) (10% of the Ex-works price of undelivered material) towards liquidated damages.
- (ii) Your firm, M/s Remi Industrial Products, Bhopal having following address & other details, is hereby debarred from future business with M.P. Poorv Kshetra Vidyut Vitaran Co. Ltd., Jabalpur for a period of two years from the date of issue of this letter:-
