Please refer correspondence 1st to 9th cited above, regarding supply of spares for 11 KV 200 A / 400 A (Conv.) and 11 KV 200A (T) AB Switches on the rate contract order valid up to till the new rate contract is finalized after 1 year against rate contract order no. PM-2866, dt:12-08-2011

Vide reference 10th cited above, a final notice was issued to your firm to dispatch the consignments of LPOs placed by respective circles within 15 days, stating that “failing which action will be initiated against your firm as per terms and conditions of the rate contract order cited without any further notice”. But there was no response from your firm to-date.

EPDCL management has viewed seriously the above non adherence in supply of materials for which LPOs placed by respective circles as non compliance and deliberate breach of the terms and conditions of the Rate Contract Order placed on your firm, since your firm failed to take immediate steps until now to supply 100% quantity of material for which LPOs placed by respective circles.

Such un professional and irresponsible response of your firm in supply of the required ordered material, put the EPDCL in quandary, besides wasting its valuable time, energy & resources. In the wake of non supply of material by your firm in a crucial time, EPDCL has to procure material from other alternative sources to cope up the extreme demand faced across the five districts, which has caused additional burden to the EPDCL, besides tarnishing its image and paralyzing the execution of targeted works.

In view of the above, without prejudice to rights and contentions of EPDCL, the management has decided to cancel the rate contract order placed on your firm for supply of spares for 11 KV 200 A / 400 A (Conv.) and 11 KV 200A (T) AB Switches against rate contract order no. PM-2866, dt:12-08-2011 duly black listing your firm for a period of 2 years for the blatant failure on the part of your firm in supply of ordered material as per the terms and conditions of Rate Contract Order besides forfeiting Bid Security paid vide DD No. 478741, dt:28-06-2011 for Rs. 25000/- available with APEPDCL.
