In the reference 3<sup>rd</sup> cited, the Superintending Engineer/TL&SS Circle/ Rajahmundry has submitted that you have not made payments to the contract labour at 132 KV SS Pithapuram since February'2014 & VDA from 12-12-2013 even though notices issued by Superintending Engineer/TL&SS/ Rajahmundry.

A show cause notice was issued to you vide reference 4<sup>th</sup> cited by registered post from the O/o. Chief Engineer/Visakhapatnam Zone/A.P.Transco with a request to intimate as to "why your firm should not be kept in "BLACK LIST" besides terminating the subject work for non payment of wages to contract labour from February'2014 & VDA from 12-12-2013".

The show cause notice delivered on 27-06-2014 and no reply was received against the above notice from you within the stipulated period.

Hence the following work awarded to you is here by terminated w.e.f.01-02-2014 besides black listing your firm for 2 years to participate in future tenders of A.P.Transco as per payment clause No. 11 payment/ terms and conditions of the


tender specification of O&M of EHT Sub-stations clause No.7(c) of LOI and clause No.11 (i) of agreement under Annexure-II for non payment of salaries to contract labour w.e.f.01-02-2014 in respect of Highly Skilled labour & Skilled labour and w.e.f. 01-03-2014 in respect of Un-skilled labour & VDA from 12-12-13 to all categories of contract labour working in the subject work duly forfeiting the security deposit available against this work.

1. Carrying out Operation & Maintenance including watch and ward by providing 4 Nos. Highly-Skilled, 4 Nos. Skilled and 3 Nos. un skilled persons at 132 KV SS Pithapuram.
