Dear Sir,

This office Purchase Order No.3591 dated 11.05.2011 was placed on you for supply of 5000 Kg of SF6 Gas filled in 100 nos. of Cylinders. But you have intimated vide your letter mentioned at SI.2 under reference above that you will not be able to supply the SF6 Gas to OPTCL at your quoted price.

Please note that your refusal to supply SF6 Gas after receipt of the final Purchase Order has resulted in loss of time as well as caused great inconvenience to OPTCL.

The matter was considered by the competent authority of OPTCL and it has been decided as followed:-

- 1) This office P.O. No.3591 dated 11.05.2011 is hereby cancelled.
- 2) The EMD amount of Rs.56,000/- deposited by M/s. Ultra Pure Gases (I) Pvt. Ltd. is hereby impounded.
- 3) ~~M/s. Ultra Pure Gases (I) Pvt. Ltd., Baroda is hereby black listed and debarred from participating in any tender or business dealings of OPTCL for a period of three years from the date of issue of this letter.~~
