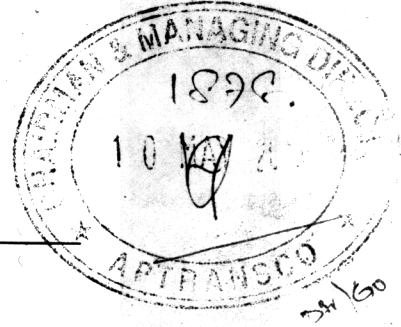

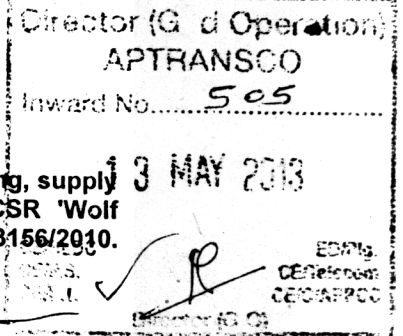

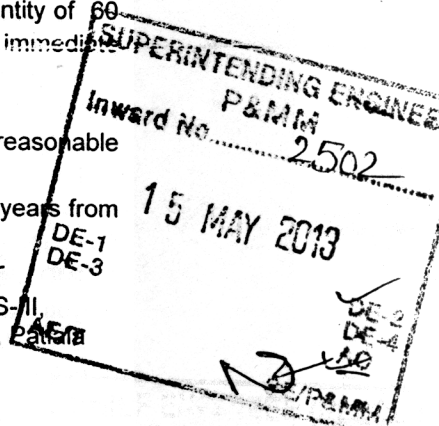


AMENDMENT NO. I
