As per the Joint Managing Director (V&S), A.P.TRANSCO, Vidyuth Soudha  
Hyderabad recommendations vide reference cited above, the contractor M/s.United  
Power Agency, Nidadavole has committed the following irregularities during the  
validity period (upto 30.06.2013) of contractor registration for the work " O&M of  
Sub-station" under class III in entire APEPDCL.

- ❖ The contractor M/s. United Power Agency who miserably failed to draw  
and pay the salaries to the Shift Operators working in Kanuru Sub station  
from 05.10.2012 till date (as on the date of enquiry) by violating the  
conditions of the agreement and also for demanding money from the Shift  
Operators towards regularization of their service.

As per clause No.(8) (i) of Terms and conditions of the Contractor Registration  
procedure, the registering authority reserves the right to cancel or demote or  
suspend from business or black list without any notice and without assigning  
any reasons there of.

In view of the said allegation against you, the contractor registration  
accorded vide registration No.00446/CORP is hereby cancelled and kept the  
contractor in black list for 3 years from the date of this notice.
