1. As per recommendations of the Superintending Engineer / Operation / Eluru and detailed enquiry report of the Superintending Engineer/DPE/Visakhapatnam, the contractor Sri K. Ramdayal billing contractor while doing spot billing works at Penugonda Section has committed the following irregularities during the validity period (upto 31.07.2015) of contractor registration bearing regn.No.00098/CORP.
 - a. Sri K.Ramdayal and his workmen while doing spot billing in Penugonda Section in Vadali distribution he has suppressed meter readings causing huge revenue loss to the department violating the Agreement clause 30.
 - b. Sri K.Ramdayal has taken the amounts from the consumers of Vadali distribution and also collected new clothes from the consumer of Handloom weavers Association building.
 - c. Sri K.Ramdayal has intimidated and black mailing the Co. Contractors for not listening to his word by citing small reasons like billing delayed, Service Tax not paid etc.
 - d. Sri K.Ramdayal has also black mailing the department officers by making false complaints to the Hon'ble Chairman & Managing Director those who are questioning his misdeeds.

- e. Sri K.Ramdayal has stopped spot billing in Penugonda Section for the month of 06/2015 without giving any notice to the local authorities because of which consumer billing was delayed.
- f. Still some of the Co-contractors and department persons are informing orally but fearing to give the statements against Sri K. Ramdayal billing contractor is a black mailer and not to renew contractor registration and not allowed to do spot billing work.
2. As per clause No.(8) (i) of Terms and conditions of the Contractor Registration procedure, the registering authority reserves the right to cancel or demote or suspend from business or black list without any notice and without assigning any reasons thereof.

In view of the said allegation against you, the contractor registration accorded vide registration No.00098/CORP is hereby cancelled and kept the contractor in black list for 3 years from the date of this notice.
