Further, application received for registration vide application dt: 18.12.2013 for Erection & maintenance of lines, Man power supply and O&M of substation furnishing 'A' Grade licence.

It has come to the notice of the undersigned that Smt. B. Lahari, contractor is participating in tenders with bogus 'A' Grade license. The Secretary, A.P. Electrical Licensing Board, Mint Compound has confirmed that the certificate produced by Sri B. Janardhan Naidu, contractor, is a fake and fabricated/forged document.

After careful examination and in terms of registration of contractors policy (2006) of APCPDCL the application for registering Smt. B. Lahari, Kurnool as class-I contractor for **Erection & Maintenance of Lines, Man Power Supply and O&M of Substation** works is hereby rejected duly forfeiting the DD amount of Rs.3100/- (SBI Bank, NGO Colony, Nandyal Branch, Dt: 11.12.2013).

Further, **Smt. B. Lahari, Kurnool is placed under BLACK list.**
