In the T.O.O 1st cited, certain AEEs/Civil were appointed through direct Recruitment in the year 2011 and are to be place below Smt. K. Siva Jyothi, AEE/Civil who is the last candidate of the 2010 batch.

2. In the reference 3rd cited, Smt M. Jahnvi, was considered for conversion as AEE/Civil upon acquiring the BTech(Mechanical) qualification and placed below the 2011 batch as per the date of conversion.

3. In the T.O.Os 4th and 5th cited, certain Assistant Executive Engineers (Civil) were appointed during 2017 through direct recruitment on zonal basis, by following Rule of Reservation and the Presidential order (i.e., Local & Nonlocal), for each zone.

4. In T.O.O.(Per-Addl.Secy).Ms.No.13, dt.07.04.2011, it was ordered that the inter-se-seniority prepared and maintained in the respective units shall be consolidated on merit cum seniority basis at the Head Quarters and the same shall be followed for promotions to the next higher cadre.

5. Subsequently in the letter 2nd cited, it was ordered that commencement and completion of probation in respect of these AEEs recruited on zonal basis shall be ordered as per their allotment without linking it to the seniority.
6. In the reference 6th cited, Smt G. Nikhila, Graduate Sub Engineer with BTech/Mechanical was appointed by transfer as AEE (Civil) and she is placed below Sri Kolaventi Rajkumar, AEE/Civil, who is the last candidate of the 2017 batch of AEE(Civil).
7. Further, Sri Chityala Krishna Sumanth, Graduate Sub-Engineer was considered for appointment by transfer as Assistant Executive Engineers (Civil) and placed below Smt G. Nikhila, AEE/Civil, as per reference 7th cited.
8. After careful consideration the provisional seniority list of the above category of AEE's/Civil has been prepared, duly placing them below Smt K. Siva Jyothi, AEE(Civil) who is the last candidate in the 2010 batch and the same is communicated in the annexure appended to this order.
9. The provisional integrated seniority list of AEEs(Civil) appointed by transfer/converted/ recruited in 2011 & 2017 has been consolidated in terms of T.O.O. Ms.No.13, dt.07.04.2011, and is placed on the Official website of APTransco at (www.aptransco.gov.in).
