An enquiry was conducted by the Vigilance wing on the allegations against Sri.S.K..Jamsheer Ahamed, manning contractor M/s.Faizan Electrical & Civil Contractor, Kanigiri against the manning contract works awarded to them at 220 KV SS Podili, 132 KV SS Pamuru and 400 KV SS Podili.

The Vigilance enquiry recommended necessary action against Sri.S.K..Jamsheer Ahamed, manning contractor for 220 KV SS Podili, 400 KV SS Podili and 132/33 KV SS Pamuru for not following the ROR in recruitments of 220 KV SS Podili and 132 KV SS Pamuru, not giving wide publicity in the news papers and not arranging drop boxes at the time of recruitment in all 3 Nos. Sub-stations (220 KV, 400 KV and 132 KV SS).

It was also stated that Sri.S.K..Jamsheer Ahamed, M/s.Faizan Electrical & Civil Contractors are doing manning contract works without valid license and violating the rules and regulations in recruitment of contract/ outsourcing jobs as part of manning contract works.

In view of the above and as per the clause (3) of L.S.Agreement No.24/2012-13 of the Superintending Engineer/TL&SS/Nellore. (For 220 KV Podili SS), as per clause 22 (b) of LOI (reference 7<sup>th</sup> cited) and clause 3 & 32 (i) of L.S.Agreement NO.26/2018-19 of the Superintending Engineer/ 400 KV/OMC/Vijayawada (For 400 KV Podili SS), as per clause (4) of L.S.Agreement No.39/2010-11 of the Superintending Engineer/TL&SS/Nellore and clause (3) and (29) of L.S.Agreement No.25/2012-13 of the Superintending Engineer/ TL&SS/Nellore the following man power contract agreements awarded to you vide references 3<sup>rd</sup> and 4<sup>th</sup> cited and 7<sup>th</sup> & 8<sup>th</sup> cited are cancelled with effect from 31-08-2021 and the contractor Sri.S.K..Jamsheer Ahamed, M/s.Faizan Electrical & Civil Contractor, Kanigiri is black listed for a period of 3 years i.e. from 01-09-2021 to 31-08-2024 as per the instructions of issued by APTRANSCO Head Quarters.
